COVID-19 SAFETY RULES and SPECIFIC TRIAL INFORMATION:

- **We will offer Day-of-Show entries and entry forms will be available at the trial site at a separate table from the Trial Secretary station. Please be prepared to use social distancing procedures while filling out forms, keep masks on, and use hand sanitizer when needed.**
- **Grooming and crating are permitted inside the building but no dryers allowed. Generators will be allowed outside. Please maintain six foot distance between grooming areas.**
- **Masks are required to be worn at all times in and out of the ring.**
- **Separate ring entrance and exit will be provided.**
- **Use social distancing procedures while inside the show building, keeping yourself and your dogs six feet from other participants and workers at all times.**
- **Do not attend the event if you have any illness symptoms, or if you believe you've been exposed to someone who tested positive for Covid-19. We reserve the right to excuse anyone who is showing signs of illness.**
- **SCASC and its representatives reserve the right to request that anyone not following these safety rules and procedures leave the facility immediately. No refunds will be available to anyone being asked to leave.**

GENERAL INFORMATION:

1. All entries must be submitted on the latest approved ASCA entry form, for the event in which your dog is entered. Entry forms are available on the ASCA website, at www.asca.org/home/business-office/rules-forms.
2. No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.
3. Refunds of pre-show entries will be refunded only upon written request prior to close of pre-entries. No other refunds will be granted. No class changes will be allowed once entries have closed on the day of the show or trial.
4. Any check returned to our bank will invalidate all entries associated with that check. Writer of the check will be required to pay a \$50 administrative fee, in addition to all bank charges associated with the returned check. If the issue is not resolved within 10 days, the writer of said check will be reported to ASCA.
5. Dogs over 6 months of age must have proof of ASCA registration available.
6. SCASC, the show secretaries, and club membership assume no responsibility for any loss, damage or injury sustained by any exhibitor, handler, dog, property, children or spectator.
7. All dogs must be crated or leashed except while competing.

8. Show building will be open and available to exhibitors for setup at 7:30 am on Saturday, and at 8:00 am on Sunday. Building will be closed and locked each evening. No dogs may be left in show building overnight. Contact Show Coordinator for information regarding building access.
9. Shows will be held indoors, on concrete floors covered with rubber matting. Crating space and grooming spaces are available in the building. Electricity is available but no dyers allowed due to Covid restrictions.
